**FOLLOWING FORMS OF PARTICIPATION IN THE CONFERENCE ARE OFFERED:**

1. Oral presentation (10 min) and Poster presentation (5 min *online* with questions in chat).
2. Theses publication (requirements for theses — see Appendix 1).
3. Publication of presentations (oral/poster) materials in the form of an article with provision **doi (Digital object identifier)** in the specialized journal "Pharmacology and Drug Toxicology" (the volume of the article manuscript is up to 12 pages).

The **requirements for article** composing correspond to the requirements posted on the website of the journal "Pharmacology and Drug Toxicology". (available by the link: <https://pharmtox-j.org.ua/index.php/pharmtox-j/about/submissions>).

**Official languages** of the conference are Ukrainian & English.

All procedures describing experiments involving laboratory animals, works using materials obtained from donors or patients, should be conducted guided by bioethical norms in accordance with the recommendations of the European Convention on the Protection of Vertebrate Animals Used for Research and Other Scientific Purposes (Strasbourg, 1986), Law of Ukraine No. 3447-IV "On the Protection of Animals from Cruelty" (Kyiv, 2006), Declaration of Helsinki (Helsinki, 1964).

Requirements for oral presentations: approximate duration-up to 15 minutes.

**Appendix1****THE REQUIREMENTS FOR SCIENTIFIC CONFERENCE ABSTRACTS  
(THESES) COMPOSING****"PHARMACOLOGY AND DRUG TOXICOLOGY"**

Theses of reports should correspond to the theme of the conference. Languages: Ukrainian, English. Theses are printed with 1 space, in Times New Roman, 12 font. Paper and electronic versions of the manuscript must have the following margins: left - 3.5 cm, right - 1.5 cm, top and bottom - 2.5 cm. The text of theses **should not contain figures, tables, formulas and references to literature**. The text of report's theses should not be less than 300 characters and not exceed 2500 characters, including spaces. The file name must contain the author's last name in English (for example, *Ivanenko.doc*).

The structure of theses reports: 1) the full title of the work (in capital letters); 2) surnames and initials of the author/authors; 3) full name of the institution, institution(s), city, country; 4) research purpose; 5) materials and methods; 6) research results and discussion; 7) conclusions\*.
